ACT

It is HEREBY enacted by the State Assembly in the Fifty-fourth Year of the Republic of India as follows:—

Short title,  
Extent and  
Commencement

1. (1) This Act may be called The Uttaranchal (The Uttar Pradesh Entertainments and Betting Tax Act, 1979) (Adaptation and Modification Order, 2002) (First Amendment) Act, 2003.

(2) It extends to the whole State of Uttaranchal.

(3) It shall come into force with immediate effect.
